I, the enrolled participant and/or the parent/guardian of the participant (if applicable) agree and understand that swimming is a HAZARDOUS activity. I recognize that there are risks inherent in the sport of swimming, including but not limited to, paralyzing injuries and death.

The participant hereby agrees to participate in the swimming event and associated activities and/or programs and hereby agrees to indemnify and hold harmless: Aqua Moon Adventures and/or its sponsors, agents, directors, officers, volunteers, and employees, including the race committee, against any liability resulting from any injury that may occur to the participant while participating in The Bonaire EcoSwim events and associated activities and/or programs. The participant also agrees to indemnify Aqua Moon Adventures and/or its sponsors, agents, directors, officers, volunteers, and employees, including the race committee, for any damages incurred arising from any claims, demand, action or cause of action by the participant.
